PhD position (70%)

to start from February 2026 (or by agreement) for a period of 4 years (renewable each year).

Applicant profile: Applicants should hold a Master's degree in economics with a focus on quantitative international, regional, or urban economics. Outstanding candidates with a Master's degree in other empirical fields may also be considered. Individuals with a strong quantitative background in related disciplines (e.g. mathematics, physics, computer science) are likewise encouraged to apply. Proficiency in English is required; knowledge of French constitutes an advantage.

Job description: The objective of the position is to write research papers in international, regional and urban economics and earn a PhD. The successful candidate will work under the supervision of Prof. Dr. Gabriel Loumeau (https://www.gabrielloumeau.com/). Research activities at his chair range from international economics to quantitative economic history. Collaboration in ongoing projects is encouraged but not required. The PhD candidate will have to complete graduate training in economics. Although the focus of the position stays on research, the PhD candidate is also expected to participate in the life of the Chair and the Institute (e.g., teach classes, organize examinations, supervise students).
